



TYPES OF FUNDS:

Emerging Fund

By establishing an emerging fund with CNDCF, you are making a pledge to your community over time. Choose any fund below and make your commitment to community. We will be able to establish a fund in any of the categories below with an initial donation and a pledge to meet one of the minimum donation levels as described below within five years.

Community Fund (named fund minimum of \$5000 pledged over 5 years)

The Community Fund is an endowed fund made up of gifts of all sizes. Unrestricted gifts allow the Community Foundation to respond with the greatest flexibility to our community's needs and changing priorities. The fund provides grants to address long-term problems and solutions; to respond to new and emerging needs; and to support the community's charitable sector. Here's the cool part; each year a dedicated and experienced Grant Selection Team works closely with local organizations and advisors to recommend grants that will have a lasting impact.

If you are looking to start a Fund in your name or in the name of a loved one, the Community Fund provides our most affordable option. With a minimum donation of \$5000, which can be pledge over 5 years, we can create a Fund in your name, under the Community Fund umbrella.

Donor Advised Funds min. \$50,000

A great option for individuals and corporations, Donor Advised Funds give our donors the chance to participate in the grant making process. Working closely with the Foundation's staff and Board of Directors, donors may identify and recommend specific charitable organizations they want to benefit from their fund.

Corporate Donor Advised Funds provide a mechanism to celebrate landmark occasions while creating opportunities for employees to be involved in community philanthropy.

Donor Designated Funds min. \$10,000

You name it. The charity of your choice will receive distributions from your Donor Designated Fund each year, forever. This fund allows donors to name one or more charitable organizations to benefit from the income generated by the fund; providing a lasting source of revenue for your favourite registered charities.

Field of Interest Fund min. \$10,000

Field of Interest Funds allows donors to specify a field of interest to be supported without naming individual charities. By defining the charitable field, grants from these funds benefit the donor's areas of interest, while continuing to be adaptable over the long term, to best serve the community's needs. Grants from these funds are awarded by the Foundation's dedicated Grant Selection Team.

Scholarship Funds min. \$10,000

Scholarship Funds provide are established in the name of the donor or in honour of an individual or business. They are used to support the educational costs of deserving students. We work with local schools and agencies to manage the application process and to issue the awards. The details are handled the CNDCF and the honour of presenting the award is yours.

Agency Endowed Funds

Agency Endowment Funds are established by charitable organizations to support their work. These forward thinking organizations realize that an Endowed Agency Fund will provide their organization with long-term stability – forever. It also provides the agency with access to the investment expertise of CNDCF's Investment Team and a closely monitored Investment Policy.
